DIRECTIONS FOR USE:

Use **United 203** for excellent odor control in **SEWAGE TREATMENT FACILITIES**. It is especially effective for controlling odors on sludge drying beds. Just hand broadcast over the area where odors occur at the rate of 1/2 to 1 pound per 100 square feet. **United 203** gives effective, long lasting deodorizing control.

Use **United 203** in **INSECT BREEDING REFUSE** and **GARBAGE CONTAINERS**. Before and after filling, sprinkle liberally. Repeat applications as necessary. The product will deodorize, while repelling ants, beetles, centipedes, cockroaches, crickets, earwigs, fruit flies, silverfish, spiders, termites, ticks and mice, rats, ground squirrels and bats that feed on refuse.

Use **United 203** for general refreshing of **AREAS TO BE SWEEPED**, by mixing the **United 203** granules in with the sweeping compound and sweeping normally.

Use **United 203** to pick up **SPILLED LIQUIDS** and other **PROBLEM SPILLS**. It will absorb moisture and oil spills.

For deodorizing **HOTEL** and **MOTEL** rooms: Upon entering the room for daily cleanup, broadcast a handful of **United 203** pellets over the carpeted area. While performing the regular linen changing, dusting and cleaning, let the **United 203** remain on the carpet. As the final cleaning step, vacuum the **United 203** from the carpet. **United 203**'s pleasant peppermint scent will remain in the room and prevent musty, unpleasant odors.

To preserve the original freshness and efficiency of the product, fold over the polyethylene liner bag and replace the lid securely. Always replace the cover on the container after use.
