### 4. FIRST-AID MEASURES

#### First Aid Measures

<b>Eye Contact</b>	Flush eyes with a large amount of water for 15 minutes. Seek medical attention immediately if any irritation persists. After first aid, get appropriate in-plant, paramedic or community medical support.
<b>Skin Contact</b>	Wash affected areas thoroughly with soap and water for at least 15 minutes. Cover the irritated skin with an emollient. Remove contaminated clothing and shoes. Cold water may be used. Wash clothing before reuse. Thoroughly clean shoes before reuse. Seek medical attention if any irritation persists.
<b>Inhalation</b>	Remove to fresh air. If not breathing, give artificial respiration. If breathing difficult, give oxygen. Call a physician if any difficulties persist.

**Methods and material for containment and cleaning up**

**Small Spills** Absorb spill with paper towel or similar absorbent; or flush to sewer or ground with large amounts of water.

**Large Spills** For large spills, dike far ahead of liquid spill for later disposal. Do not release into sewers or waterways. Absorb spill with vermiculite, oil dry or similar non-reactant absorbent. Solidified product represents no environmental hazard.

**Clean-Up** Accumulate the absorbed materials and dispose of according to federal, state and local regulations.

**7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Advice on Safe Handling** Use the recommended safety controls and personal protective equipment as outlined. Fully review all data before handling of the material itself. **Appropriate engineering controls**
